

**HOW TO USE THE SEAT BUS SYSTEM
Flag-Down System**

Bus will not stop at a location if passenger safety is at risk.

Corridor Service

Routes #1, #101, #2, #3, #9 connect the major cities and towns in S.E. Connecticut.

Local Service

Routes #4, #5, #6, #7 serve Norwich and end at Norwich Transportation Center.

Routes #12, #13, #14 serve New London and Waterford and end at New London Water St.

Route # 11 serves Groton and ends at Plaza Court

Route #8 serves Jewett City and ends at Lisbon Landing.

Free Transfers

Transfers allow customers to complete a one-way trip which requires multiple buses without additional fare payment.

Transfers cannot be used to make a round trip. Transfers are issued upon request, and are time-limited, and are only accepted at designated Transfer Points: Norwich / NTC*, Lisbon Landing, Mohegan Sun, New London/Water St**, New London / NSA, New London / Eugene O'Neill and State Street Shelter, Groton Square, Groton Plaza Court, I-95 / Route 2 Commuter Lot (N. Stonington), Olde Mistick Village

Fares Effective 1/2/18

The fares shown below are for one-way trips only. You must have exact fare. Drivers do not handle money.

All tickets/passes are non-refundable

Cash Fares:

Adult/Youth \$2.00
Senior/Disabled \$1.00 (proper i.d. required for reduced fare)
Children 5 and Under (about 45" and below) Free

Tickets:

Ten (10) Ride Ticket Book \$20.00
Ten (10) Ride Senior/Disabled Ticket Book \$10.00 (proper i.d. required for reduced fare)

Passes:

Four (4) Hour ZIP Pass: \$3.00
Ten (10) Ride Pass \$18.00
Ten (10) Ride Senior/Disabled Pass \$9.00 (proper i.d. required for reduced fare)
One (1) Day Unlimited Ride Pass \$4.00
Five (5) Day Unlimited Ride Pass (consecutive days) \$20.00
Thirty-One (31) Day Unlimited Ride Pass (consecutive days) \$50.00

Note: The Unlimited Ride passes are activated when first used on the bus. Day passes and ZIP passes sold on the bus will be activated upon issue. Passes are non-transferable.

Reduced Fare

REDUCED FARE: Senior Citizens and persons with disability can travel for a reduced fare at any time. To receive the reduced fare privileges, display your Medicare Card., or your Senior/Disabled Transit Photo I.D. Card to the driver. The Senior/Disabled Reduced Fare Photo ID Card can be purchased from the CT Transit Senior/Disabled Representative @ 860-522-8101.

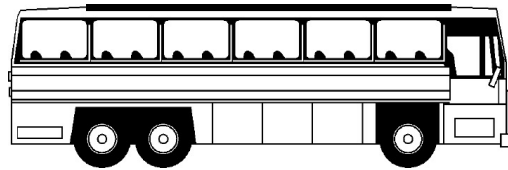
